After interaction with the empanelled Chartered Accountants/Cost Accountants and considering the points deliberated during the meeting, it was decided that an online fee proposal format be provided to the Chartered Accountants/Cost Accountants for submission of their written comments and suggestions. The matter, along with the inputs received from them, shall be placed before the Authority in its next meeting for further consideration and a final decision".

Item No.3: To discuss with the software development team of MAHA IT about the development of comprehensive new software for the Authority.
